In continuation to the Circular Memorandum in the reference 7th cited for the implementation of the District Level Business Reforms Action Plan, the following instructions are issued to the enforcement officers and licence issuing authorities of this Department.

- 1) Under the Contracts Labour (Regulation and Abolition) Act, 1970, Renewal of license for contractors those who are already registered in the Online Web Portal, an automated system for renewal is introduced in the Labour Department Online Portal.
- 2) Under the Inter State Migrant Workmen (RE&CS) Act, 1979, Renewal of license for contractors those who are already registered in the Online Web Portal, an automated system for renewal is introduced in the Labour Department Online Portal.
- 3) Under the Legal Metrology Act, 2009, those who have already registered in the Online Web Portal for Manufacturer / Dealer / Repairer licenses, an automated system for renewal is introduced in the Labour Department Online Portal.

- 4) Enforcement Officers of this Department are requested to accept the maintenance of Online / Digital Registers as per the provision under Section 4 of the Information Technology Act, 2000.

All the enforcement officers are informed that under the above said Act and Rules, an automated renewal system is introduced in the Online Web Port and all are instructed to follow to the above guidelines strictly.
